Webmaster Report:

Hello family, I apologize for the website being down over the last month. It is my best belief that I have finally gotten the website situated.

Firstly, I want to explain that the website suffered a DOS attack last month. A DOS attack spammed the hosting providers web server. As a result, they shut our website down.

A DOS attack makes thousands of requests to the server at one time. Making our hosting provider believe that we had used our allotted CPU clocks for the month. Which resulted in them shutting down the site for the rest of the month.

Please rest assured that the website does have security measures on it. However, those security measures are provided by the hosting provider. I personally am not pleased about how they handled the attack. The attack is over, and our CPU clocks reset on the first of this month.

The second problem that I addressed this morning is that I reduced the size of our SQL database, which was making the website run slowly.

I truly believe that all is situated now. I do think that the hosting provider is money hungry... that doesn't mean we have to give it to them.

I received a verbal estimate for making a new website for us. The company told me that it would cost around \$600.00. I think that is too much money to spend on a website. I do not know enough at this point in my education to be able to build a entire website from scratch.

The hosting plan expires on April 30th. It will renew at \$359.88 for the year.

The domain name will expire on May 4th and will renew at \$21.99.
